3	Eligibility Conditions	<ul style="list-style-type: none"> a. All regular serving employees and lien holders of Divisions in Level-1 & Level-2 including Safaiwala of Operating and Commercial Department of SBP, WAT & KUR Division are eligible to apply for selection in terms of RBE No. 16/2021. b. The candidates must have completed minimum 02 years of continuous service in the relevant grades on successful completion of probation period irrespective of the fact whether such staff belong to Gen/OBC/ST/ST in terms of RBE No. 38/2017. c. For the staff working in Level-2 who have less than two years service in existing grade, the service rendered in Level-1 will be reckoned/ counted towards the 02 years service conditions. d. The cut-off date for determining the residency period for eligibility of staff shall be the date of issue of notification in terms of RBE No. 117/2006.

		<p>e. Candidates should have possessed the prescribed medical standard of B-2 (Bee-Two) in terms of Estt. Srl. No. 57/2019. The staff who does not have the requisite medical standard may also apply for selection but their empanelment will be subject to passing the medical examination in B-2 (Bee-Two) medical category after qualifying in the written examination.</p>
5	Syllabus	Syllabus are enclosed at Annexure-B (Commercial Department)
6	Medical Qualification & Training:	The promotion to the post of Commercial-Cum-Ticket Clerk in Level-3 in Commercial Department is subject to fulfillment of required medical classification ie. B-2 (Bee-Two) and also passing promotional course of training from an Authorized Training Institute.
7	Mode of Selection	<p>The eligible staff who satisfy the above prescribed conditions of eligibility will be called for selection which will comprise of written examination in CBT Mode followed by scrutiny of Service Record, APARs for the last three years etc. in respect of candidates who qualified on the written examination.</p> <p>Written Examination</p> <p>i. In order to bring objectivity to the selection process, it has been decided by Railway Board Vide RBE No. 196/2018 that the questions for the written examination will be 100% objective multiple choice type both in Hindi & English.</p> <p>ii. Accordingly, written examination will comprise of one Professional Paper of 100 marks as per the prescribed syllabus. The question on official language policy will be of 10 marks i.e., 10% of maximum 100 marks, but these question will not be compulsory.</p> <p>iii. There shall be negative marking for incorrect Answers. One-third of the marks allotted for each question will be deducted for wrong answers (RBE No. 194/2019).</p> <p>iv. The written examination will be a computer based test (CBT)/Tablet Based Test(TBT) where there will be no physical question paper. All the questions will appear on the Computer/Tablet and the employee will have to mark their responses/answers to the question on Computer/Tablet.</p> <p>v. In terms of RBE No-91/2022, Answer key will be published on the ECoRly website after completion of main written exam and supplementary exam if any.</p> <p>vi. Answer/Response sheets will be evaluated in terms of RBE No-59/2022 & 122/2023 through computerization mode.</p> <p>vii. Both physical and biometric attendance marked at the examination venue.</p> <p>a. Being a general selection post, panel will be drawn in the order of merit based on the aggregate marks of 'Written Examination' & 'Record of Service' and there will be no classification of 'Outstanding' in terms of RBE No. 113/2009.</p>

As no physical communication will be made after issue of this vacancy notice, it will be the responsibility of the concerned employees to regularly visit [https://rrcbbs.org.in] website for an update and to download the admit card as and when made available by RRC.</p> <p>b. A link will also be made available on the above website [https://rrcbbs.org.in] to the employees, explaining as to how the question will be appearing and how to mark the responses/ answers in the actual examination.
