Sub: Appeal for remedial examination for the post of Level-1 of Centralized Employment Notice (CEN) No. RRC 01/2019.

In reference to the Centralized Employment Notice (CEN) No. RRC 01/2019, Railway Recruitment Cell(RRC), East Coast Railway, Bhubaneswar has completed the 1st round document verification of 2509 candidates and declared panels of 2307 candidates. In the said Document Verification process for the Level-1 post, the following candidate appeared for Document Verification in Railway Recruitment Cell, Bhubaneswar which was followed by the medical examination at the RailwayHospital.

However, as per the medical report received from the Railway Hospitals, the following candidates were not found fit in prescribed medical standard (A-2,A-3 or B-1) and also not considered for empanelment.

As per the instructions contained in Railway Board's letter No. 2014/H/5/8/(Policy), dated 07.07.2017, they may submit their appeal against the verdict of the Railway Medical Committee.

The Procedure of appeal is as follows:

(i) If any candidate wants to appeal against the decision of the Medical Committee, he/she should submit his/her appeal to the Principal Chief Medical Director of East Coast Railway within the period of one month from the date of issue of this letter with due justification. The appeal so addressed to the *Principal Chief Medical Director, East Coast Railway*, *Bhubaneswar* should reach at the following address by Speed Post or delivered by hand in any working day:

To, Assistant Personnel Officer (HQ), 2nd Floor, South Block, Rail Sadan, Chandrasekharpur, Bhubaneswar, Odisha, PIN -751017.

(ii) Such an appeal shall be entertained, only if the candidate produces a medical certificate from a Government/Private doctor of the Speciality/Specialities in which the candidate has been found Unfit. Such certificate should contain a note that "The Government/Private Specialist is fully aware of the physical and visual standards set by the Railways for the particular medical category and that he/she is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate medical board comprising of three Senior Railway Doctors appointed by the Government in this regard".

The certificate should bear the photograph and marks of identifications of the candidate duly attested by such a Government/Private issuing authority. Such an issuing authority shall also clearly mention his/her full name, designation, address etc. and his/her Medical Council of India/State registration number.

If you wish to appeal against this medical verdict, kindly send your appeal as indicated above to Railway Recruitment Cell, Bhubaneswar by 29.07.2023 with the following threedocuments.

- a) Appeal with justifications duly signed by the candidate indicating his/her Roll No., Registration No. and date of Document Verification. Annexure-B.
- b) Medical certificate issued by Government/Private Specialist as per the format enclosed as Annexure-A.
- c) A Demand Draft for Rs.1000/- (Rupees one thousand only) in favour of FA & CAO, EastCoast Railway, Bhubaneswar.
